NOTICE INVITING TENDER

Sealed competitive tenders are invited for and on behalf of Kerala Health Research and Welfare society from GMP Certified Manufactures / Approved Suppliers / Distributors for the supply of STD Consumables, Reagents, Test Kits etc., .

- 1. Tenders sealed and endorsed as such with the name of schedule clearly written thereon shall be delivered at the office of the KHRWS at Thiruvananthapuram not later than 5 PM on 015-10-2015 Last date sale of tender for supply of Consumables, Reagents, Tet Kits etc., required for the Laboratories including Cath Lab, ACR Labs and other unit under KHRWS on 12-10-2015 at 3 PM and date of opening is on 16-10-2015 at 11 AM. Tenders will be opened at the office of the KHRWS by the Officer in charge of such officer as may be authorized on his behalf in the presence of such of those tenderes or by the authorized agents as may be present at 11.00 AM on the same day. The total amount quoted for each items will be read out the tender and all corrections in the tender will be attested by the tender opening officer with dates and initials.
- Each tender shall be accompanied by an Earnest Money Deposit by way of DD @ 2% of the cost of items. Tender not accompanied by the Earnest Money Deposit will not be considred. The Earnest Money shall be in the form of Crossed Demand Draft drawn in favour of "The Managing Director, Kerala Health Research & Welfare Society" payable at Thiruvananthapuram. EMD in any other form will not be accepted.
- 3. The tenderer shall carefully study the specifications and all the documents which form part of the Agreement to be entered into by the accepted Tenderer. The documents connected with the contract such as specifications, place of supply etc., can be seen on all working days during office hours.
- 4. The acceptance of the tender rests with the Managing Director of the KHRWS, who doest not under take to accept the lowest or any particular tender.
- 5. The items should be supplied through out the state (All units under KHRWS)
- Tender shall demonstrate the equipments and specifications before technical committee consituted by KHRWS at KHRWS office.
- The KHRWS is at liberty to split the quotation of items and award to more than one tender or to delete a portion of the items at its discretion.
- 8. Tenders not submitted in forms issued from the office of the KHRWS or submitted incomplete in any respect whatsoever, such as unattested errors and corrections in rates quantitites units of amounts (figures not expressed in words) total of contract not entered etc., shall be liable to summarily rejection.
- 9. The sanctioning authority reserves the right to reject any tender or all the tenders without assigning any reasons thereof.
- Tenders which are not in coformity with this tender notice are liable for rejection. The tender notice with conditions stated therein will form part of the contract documents.

- 11. The quantities of regular items given in the tender schedule are only provisional and are likely to vary during executive / supply depending on actual requirements. In all such cases, the tenderer is bound to supply the items as per the instructions of the Officer-in-charge at no extra cost to the KHRWS.
- 12. Penal clause(s) will be in conformity with the clause(s) as in force in the Government of Kerala.
- 13. Payment will be made only after the successful completion of the supply of itemns as per the written instruction of the Officer-in-Charge, and after recording necessary stock entry certificate by the concerned officers of the institutions.
- 14. The tenderers shall submit along with the tender documentary evidence of their previous experience in carrying out similar supply and of their eligibility in support of their claim for consideration in the matter of award of contract.
- 15. If at any time, any question, dispute or difference whatever shall arise between the two parties (KHRWS on the one hand and Tenderer on the other hand) in relation to the purchase either of the parties may give to the other notice in writing existence of such a question, dispute or difference and the same shall be referred to two arbitrators, one to be nominated by the firm. Either party shall serve such a notice of the existence of any question, dispute failing which all right or claims shall be deemed to have been forfeited and absolutely barred, Before proceeding with the reference the attributors shall appoint nominate an umpire. In the even of the attributors not agreeing in their award the umpire appointed by them shall enter upon the reference and his award shall be binding on the parties. The venue of the arbitrators shall be at KHRWS office at Thiruvananthapuram.
- 16. The courts at Thiruvananthapuram will have the jurisdiction to try any matter of dispute or reference between the parties arising out of the contract.
- 5% Processing charges on basic price will be levied by KHRWS on all items purchased.
- The tenderers are required to quote their rates on Schedule provided with the tender. The rates are exclusive of tax and have the minimum life period of 24 months from the date of supply.
- 19. If any tender withdraws from the tender before the expiry of the period fixed for keeping the rates from the acceptance of earned money, if any deposited by him will be forfieted to KHRWS or such action taken against him as KHRWS thinks fit.
- Tenderers shall invariably specify in their tenders the delivery conditions including the time required for the supply of articles tendered for.
- 21. Tenderers shall clearly specify whether the goods are offered from the indigneous Source from imported under a license. Government reserve the right to reject offers for import of goods, if the import trade control policy in force at the time of award of the contract prohibits of restricts such imports.
- 22. The tender shall supply of items required for the period of one year with effect from the date of stamped agreement executed by the supplier firm.
- 23. The prices quoted should be exclusive of all taxes, duties cases etc., which are or may become payable by the contractor under existin g or future lay or rules of the country of origin supply or dlivery during the course of executions of the contract.

- .24. The successful supplier must make arrangements to transport the items to the destination specified by KHRWS at the cost of the supplier.
- 25. The successful tenderer will have to execute an agreement in Kerala Stamp Paper worth Rs. 500/- with the Managing Director, KHRWS, Thiruvananthapuram.
- 26 The price should be quoted in Indian Rupees and should include the cost of all accessories etc.,
- 27. The items shall carry IS/ISO mark certificate.
- 28. Name and address of the institution when the items have already been supplied by the tender.
- The firm who quoted the lowest rate will be called for negotiation.
- 30. All tenderers should submit the samples of items to the Cath Lab (items for Cath Lab) and ACR Lab (ACR Lab items) Thiruvananthapuram for confirmation by way of assessing the quality of products to be supplied.
- The tender document shall be duly signed by the supplier.
